Waple Family Proud Habitat Homeowners

Dessi Waple's dream was to have a home that she could pass on to her son, Tylan. She moved frequently when she was growing up, and she wanted her son, now 10, to have established roots.

Her dream came true in June.

"They say it takes a village to raise a child and I hope the Habitat Village, from the staff to the volunteers and everyone who donated to my home, realize that you have helped me develop values and the feeling of stability and security with my son," Waple said.

Her home was sponsored by Thrivent Builds/Lutherans for Habitat, their sixth home they've built together as partners in the last four years and the 20th for the Lutherans.

Waple had been living in an apart-

Shadewood Place in Full Swing

Habitat for Humanity of Evansville broke ground on its newest development, Shadewood Place, in June and had 12 homes underway by the end of October. The development, located at the corner of Shadewood and Sweetser avenues, will be a mixed-income neighborhood with 19 Habitat homes and up to four market-rate homes built by Bussing Construction.

Sponsors of the homes include the City of Evansville, Catholics for Habitat, Crossroads Christian Church, Old National Bank, Larry Dunigan/Holiday Management, the Women Build, Mike and Hope Staubitz/Staubitz Charitable Trust, an anonymous donor, young Evansville leaders, Indiana University alumni and a group of United Church of Christ and Disciples of Christ churches.

Shadewood Place is part of the overall Glenwood Community Development Initiative, an effort among many partners to revitalize the Glenwood neighborhood. The partners have been meeting for two years to map strategies to improve the area, conducting focus groups and holding community discussions, and have developed six priority areas to guide their activities – Housing and Infrastructure, Education, Clean and Green, Safety, Business and Commerce and Health and Wellness. In addition to Shadewood Place, the partners also planted a community garden, and the Glenwood Leadership Academy opened this year as a K-8 school. Plans now include bringing the city's greenway path in front of the school.

"This transformation takes a lot of work and a lot of collaboration," Evansville

Gearing Up in Glenwood

Letter from the Executive Director



Dear Friends,

We are wrapping up another successful building year with 25 families served in calendar year 2010. We have also been learning much about building sustainable and healthy communities as we work with collaborative partners in the Glenwood Community Development Initiative.

We and our partners have accomplished much in Glenwood this year. In addition to the 25 families we've served, Habitat has also secured building sites for 2011, and the first Bussing Construction market-rate home is underway.

Other improvements include infrastructure work along Sweetser, built according to the improved design to accommodate the Greenway; demolition work at Caldwell homes; and renovatons at the Glenwood Leadership Academy.

In addition to this capital investment, the Welborn Baptist Foundation has secured funding to improve access to healthy foods, Evansville Vanderburgh School Corporation created a position to support community engagement and resident leadership development, and the Vanderburgh Community Foundation is funding leadership and community development training for Glenwood residents.

In preparation for 2011, Habitat continues to approve families for homeownership and cultivate house sponsors for at least 20 new homes. Habitat is also exploring a homeowner-occupied rehabbing ministry to further our mission of eliminating substandard housing and building communities. We've learned from our work in Glenwood that existing homeowners, the most stable population of any neighborhood, need assistance. If we are to fulfill our mission of eliminating poverty housing, Habitat must seize new funding opportunities and embrace existing homeowners.

The Board of Directors and I will work diligently to attract new financial and human resources (donors and volunteers) to implement a homeowner-occupied rehab program in the Glenwood community above and beyond our new construction there. As in all new endeavors, we trust God will be walking before us.

Mayor Jonathan Weinzapfel said during the groundbreaking. "It's not just the city; it's not just Habitat; it's not just the neighborhood, or private donors or the school corporation — it's everybody working in collaboration to make this possible."

Habitat recently purchased several parcels of property along Riverside Drive in the Glenwood area and will hold them for partners in the initiative who are interested in economic development. The area is a blighted commercial district that several people working on the Business and Commerce team have expressed interest in redeveloping.

ment in an area plagued by gunfire and drug activity. She's safe now, and Tylan recently had 10 of his buddies over for a sleepover.

"My words of gratitude will never capture and express how deeply thankful and grateful I am to the Habitat program and to each and every person involved," Waple said. "Habitat is a blessing to my son and me. It has shown both of us the outcome of patience, faith, hard work and dedication as we now have a home that we worked so very hard for and sacrificed for, a home we will continue working hard for and taking pride in."

To be eligible, families must have a need, they must be willing to contribute 300 hours of sweat equity, and they must have the ability to pay their mortgage, based on a 25-year, no interest loan. Their mortgage payments are typically about \$275 a month, which is what Waple is now paying.

She and Tylan also have plans for his room — an electric train shelved high above his bed.

"His favorite color is blue, and he's hinting at painting his room that color," Waple said.

Habitat Receives Community Foundation Grant for Glenwood Leadership Training

Habitat for Humanity of Evansville received a \$20,000 Breaking the Cycle grant from the Vanderburgh Community Foundation during its annual Spirit of Giving lunch on Sept. 16. The funding will provide leadership and community development training to residents of the Glenwood neighborhood in an effort to mobilize the community around the Glenwood Community Development Initiative. The proposal was a joint effort among Habitat, the Evansville Vanderburgh School Corporation and Aurora.

"Habitat and our partners have accomplished a great deal in the few short years we have been working on this initiative," said Lori Reed, Habitat's executive director. "But one thing that has been missing is the community mobilization and training piece. This funding will help us to fill that need."

The Glenwood Initiative is a comprehensive effort among many partners to revitalize the neighborhood, identified by the Evansville Department of Metropolitan Development as an area of need. Of the approximately 600 structures in that area, about one third are abandoned and another third are rental properties of which many are in need of repair.

Additionally, 99 percent of students at the Glenwood Leadership Academy are eligible for free or reduced lunch.

The goal of the initiative is to create affordable housing, decrease transient rates among Glenwood residents and increase student achievement and attendance rates. Habitat began building in its newest development, Shadewood Place, and the school corporation opened the Glenwood Leadership Academy as a K-8 facility this year. A community mobilizer recently joined its staff to reach out to families in the neighborhood, including residents identified as proponents of the overall neighborhood stabilization initiative.

The Breaking the Cycle grant will provide community development and leadership training for those residents and will further advance the overall initiative.

Habitat Revitalizing Communities

Habitat for Humanity of Evansville has been selected as one of 163 affiliates nationwide — and the only one in Indiana — to participate in a national effort to revitalize neighborhoods. Habitat for Humanity International's Neighborhood Revitalization Initiative focuses on improving housing conditions while partnering with other community organizations to provide services that enhance the overall quality of life across struggling neighborhoods.

Habitat for Humanity of Evansville was selected to participate in this initiative based in part on its collaborative efforts to revitalize the Glenwood neighborhood. The national initiative calls for an even broader reach, however, including rehabilitating existing structures and measuring successes in a more consistent manner.

"If we are going to help families thrive in healthy neighborhoods, we have to direct some significant efforts into healing America's troubled communities," said Jonathan Reckford, CEO of Habitat for Humanity International. "These affiliates will work together to develop strategies and create strong networks that can be used to address individual neighborhood issues."

As part of the first phase, affiliates will receive training and guidance on how to revitalize communities through a variety of housing solutions and community development efforts. Habitat for Humanity of Evansville is ahead of the curve in many of these efforts, however, including the community outreach it did in the Glenwood area to ensure the voices of residents were heard.

Results from the initial phase of the national efforts will be used to develop policies and structures that can be replicated elsewhere.

"The national initiative has reaffirmed our commitment to the work we're doing in Glenwood," said Lori Reed, executive director of Habitat for Humanity of Evansville. "It has also accelerated consideration of opportunistically mobilizing resources to address the needs of existing homeowners in order to further our mission of eliminating substandard housing and building communities."

Habitat for Humanity of Evansville recognized its major donors, house sponsors and inkind contributors during its Donor Recognition Dinner Oct. 12 at St. Mary's Manor Auditorium. The event was marked by three Neighborhood Revitalization Awards presented to the City of Evansville, First Federal Savings Bank (FFSB) and the Federal Home Loan Bank of Indianapolis (FHLBI), and the Bobbie Hoy Award for Faith-Based Service presented to Crossroads Christian Church.

"When I look out and see all of you who so generously help Habitat for Humanity of Evansville build simple, decent housing, I want to assure you that you are on the right track with your priorities," said Shelley Kirk, anchorwoman for NEWS25 who emceed the event.

The City of Evansville received its award because of its substantial financial contribution to Habitat's newest development, Shadewood Place, at the corner of Sweetser and Shadewood avenues. It gave \$550,000 to build five homes and acquire and prepare properties in the Glenwood neighborhood. City Councilman Dr. Dan Adams and Jane Reel, deputy director of the Department of Metropolitan Development, accepted the award.

Monica Stinchfield, senior vicepresident of FFSB and Habitat board member, accepted the Neighborhood Revitalization Awards for her institution and FHLBI. Through these institutions, Habitat received a \$285,000 Affordable Housing Grant last year to help build 19 homes in Shadewood. Habitat also received funding from the Neighborhood Impact Program (NIP) Homeownership Opportunities Program (HOP) to help in the revitalization efforts of Glenwood. Since 1993, they have given more than \$1.1 million.

Join Habitat for Humanity of Evansville on a Mission Trip to Botswana, Africa!

Gain experiences of a lifetime while building Habitat homes in Botswana, Africa! In July 2011, Habitat for Humanity of Evansville will lead a group of 15 volunteers to Botswana where we will stay for two weeks building homes and connecting with the culture.



Botswana is one of Africa's most politically stable countries, and its diamond reserves have made a huge impact on the country's income. Half of the population, however, still struggles to survive on less than \$2 a day. One of the most vulnerable groups is women. One-third of all families are headed by females, and 60 percent of women live in extreme poverty.

In addition, the loss of lives through HIV leads to an increase in the number of child-headed households that are often left without proper financial means to support themselves or maintain existing houses.

With so many people living in poverty, substandard housing is an overwhelming challenge. Habitat for Humanity of Botswana has been operating since 1991. Since then, it has built about 1,750 homes and sold them to families at no interest. An

estimated 12,000 newly constructed homes a year are needed, however, to provide for the need.

Cost for this trip will be \$1,600 per person, which includes all in-country meals, lodging and transportation to and from the work site. This does not include air fare or optional safari. 

"We'll be able to spend our first Christmas in a home that we not only own now but that we helped build," Bratcher said.



Who We Are

Habitat for Humanity of Evansville is a non-profit Christian ministry whose mission is to build and sell simple, decent houses to hardworking families in partnership with individuals, churches, businesses, and civic organizations who share our vision.

What We Do

Habitat for Humanity of Evansville works with families whose income is less than 60 per cent of the area's median household income. To qualify for homeownership, a family must demonstrate a need for housing; have the ability to repay a 25-year, zero-interest mortgage; contribute 300 hours of sweat equity to build their own home and help other families build theirs, and attend homeownership classes to learn skills in home maintenance and financial management. No-profit loans and houses built principally by volunteer labor make mortgage payments affordable for low-income families.

Where We Work

Founded in 1984, Habitat for Humanity of Evansville currently serves families in Vanderburgh and Posey Counties. A tithing program enables Habitat for Humanity of Evansville to contribute to homebuilding in Jordan and Botswana (in southern Africa).

How It Works

Charitable contributions from individuals, churches, businesses and civic organizations provide the upfront cost of building homes. These contributions — combined with homeowner mortgage payments — create a revenue stream that enables Habitat to build more houses and serve more families.
