Hot Stove League's Night of Memories Helps Good Sports Build

Habitat's Good Sports Build project got a big boost when the Hot Stove League announced they would sponsor a house in New Haven for a family affected by the 2005 tornado.

Each year the Hot Stove League sponsors the Night of Memories to support youth programs in the local area. With an incredibly successful history of attracting professional athletes to sign autographs and a live and silent auction of one-of-a-kind sports memorabilia, the Night of Memories has become an Evansville institution. This year, proceeds will help fund a Habitat house.

"This is a leap of faith," said Paul Gries, Hot Stove League spokesperson and member of Habitat's Good Sports Build Committee. "When our members worked on the African American Churches for Habitat build, they could see the value of what Habitat is doing. They wanted to go the extra mile and raise the extra \$50,000 for a house sponsorship. Now we need the community's support."

This year's Night of Memories is slated for Saturday, February 9, at the 4-H Center, with an autograph session beginning at

2007 Year in Review

2007 was a banner year for Habitat for Humanity of Evansville with 32 homes and subdivision infrastructure simultaneously constructed. The last 15 homes started in 2007 will close on January 31 and February 28, 2008. Furthermore, we continue to fund homes in Jordan and Botswana through the Habitat for Humanity International tithe program.

Construction on the first two 2008 homes, the Industrial Contractors Build and the Boy Scouts/Cans for Habitat Build, will commence March 1. These homes are the first of 24 homes scheduled for this year. Most 2008 homes will be constructed at the New Haven subdivision.

Work in preparing for 2009 is also underway. With five builds already slated for 2009, be sure to contact Sr. Jane Michele McClure, Development Director, to secure your spot on the 2009 construction schedule as a house sponsor. With so many in our community

without decent shelter, Habitat must continue to push forward.

Robertson, Faith Build Houses Planned for 2008

Charles Robertson, who now lives in Centreville, Del., was part of Habitat for Humanity of Evansville's first blitz in 1992. He was part of the group that founded Habitat for Humanity of New Castle County, near Wilmington, which recently completed a \$6 million campaign to build 105 houses in the next five years. Charles grew up in Evansville and went to school at Dexter, Harper, and Bosse, and his father was a long-time professor at the University of Evansville. When his mother passed away in October he decided to fulfill a

long-held dream of his—to sponsor a Habitat home in Evansville in memory of her.

Benefactors Build a Winning Program

Habitat supporters have responded enthusiastically to a new program launched this fall called the Benefactors Build.

Chaired by Jim and Carol Havens, the Benefactors Build will “pool” the contributions of Habitat donors with a goal toward build-

ing a Benefactors Build house. Donors are allowed to designate their contribution for other group efforts such as the UCC/Disciples of Christ Build or the Catholic Build and still have it “count” toward the Benefactors Build effort.

“We realize that many people would like to support Habitat financially, but they find a \$50,000 house sponsorship out of reach. Though some can commit future support through planned giving, many desire a way to take part in the work that’s going on today. The Benefactors Build is a way to do that,” said Jim and Carol.

Donors who contribute over \$1,000 will be designated as “named” members of the Benefactors Build. That \$1,000 gift can be an in-kind donation, a gift of appreciated stock, a NAP contribution or it can be reached through matching contributions from American General Finance, Whirlpool, Bristol Myers/Mead Johnson Nutritionals and many other area firms.

Larry Tomlinson and Donna Cook, both members of the Habitat Partner Family Council, are featured in the Benefactors

Build brochure. Donors learn through Benefactors Build materials that families buy their homes through a 25-year, zero-interest mortgage and that partner families have a stake in the process through their investment of 300 hours of sweat equity. AT&T, City of Evansville Endowment Grants Help Habitat

Habitat for Humanity of Evansville was recently awarded an AT&T Excelerator grant, which seeks to help nonprofits build their technology infrastructure. Habitat will use the \$8,000 award to purchase software and training which will help integrate our financial and fundraising systems. AT&T Excelerator is a key component of AT&T AccessAll, which has already enabled nine of our partner families to have computer hardware and software and access to the Internet in their homes.

HFHE also recently received a grant from the City of Evansville Endowment Fund. One of the major purposes of this fund is to help projects in the Fourth and Sixth Wards of our community. For the past six years, HFHE has been fortunate to receive annual grants in the amount of \$10,000 to enable the purchase of building sites in those two wards. This year was no exception as Habitat was once again the recipient of a \$10,000 award to buy land on which to build simple, decent and affordable homes.
